VN30 performance

The VN30 index formed the closing price at 1,528 pts. Relating to foreign trading activities, buying activity kept overwhelming with net buy value recorded at VND250bn. Notably, foreign demand focused on CTG, MSN, and STB.

VN30 Future chart: Uptrend is active

VN30F2111 positively reacted with 1,500 pts zone, fading the bearish momentum and the uptrend is active. The instrument closed above major MAs, implying the active uptrend. With congestion zone, 1,500 pts zone is the short-term support zone whilst 1,580 pts zone is the next target for the upward swing. In this case, traders should open the long positions.

Technical strategy

Buy VN30F2111 after ATO session and stop the loss when there is the closing price below 1,510 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




