VN30 performance

The VN30 index formed the closing price at 1,520 pts. Relating to foreign trading activities, selling activity kept overwhelming with net sell value recorded at VND200bn. Notably, foreign selling pressure focused on VPB, HPG, and SSI.

VN30 Future chart: Consolidating

VN30F2111 kept following the short-term consolidation phase with the unclear market upcoming move. Major MAs are flat as well as Bollinger bands are narrowing, signaling the active consolidation phase. With congestion zone, 1,500 pts zone is the short-term support zone whilst 1,540 pts zone is the upward swing resistance. Trading signals are invalid due to the whipsaws market. In this case, traders should continue to hold the long positions and follow the exit plan.

Technical strategy

VN30F2111 will be expired on this trading day. Notably, trading signals are invalid due to the increase of market noise. Thus, long positions on VN30F2111 should not be closed and stop the loss when there is the closing price below 1,510 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




