The correction phase

VN30 performance

The VN30 index formed the closing price at 1,503 pts. Relating to foreign trading activities, selling activity stayed at high level with net sell value recorded at VND360bn. Notably, foreign selling pressure kept focusing on SSI, HPG, and VPB.

VN30 Future chart: The short-term correction phase

VN30F2112 has followed the downward swing, pausing the current uptrend. Major short-term MAs are downward sloping, confirming the correction phase. With congestion zone, 1,480-1,490 pts zone is the short-term support zone whilst 1,540 pts zone keeps acting as the upward swing resistance. However, the big picture still supports the upward trending market thanks to the confirmation of MA200 and MA50 (Daily chart). In this case, traders should stay on the sidelines and wait for the reaction of this instrument at the important support zone (1,480-1,490 pts).

Technical strategy

Traders should stay on the sidelines and wait for the reaction of this instrument at the important support zone (1,480-1,490 pts) due to the active medium term uptrend.



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




