# **Pullback is needed**

## **VN30 performance**

The VN30 index formed the closing price at 1,572 pts. Relating to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND700bn. Notably, foreign selling pressure focused on VPB, HPG, and MSN.

## VN30 Future chart: Intraday pullback is needed

VN30F2112 increased slightly on the previous trading day, testing the all-time high (1,560 pts zone). Major short-term MAs continue to stay below the closing price, confirming the active bullish leg. With congestion zone, 1,480-1,490 pts zone is the short-term support zone whilst 1,560 pts zone is the last resistance for the upward resumption phase. However, narrow spread candle occurred with low volume, signaling the uncertainty at the all-time high. Besides, intraday pullback is needed in order to sustain the trend. In this case, traders should hold the current long positions.

# **Technical strategy**

The captured long positions on VN30F2112 should not be closed and stop the loss when there is the closing price below 1,500 pts level (Hourly chart).










Figure 3. Future price curve
