Selling pressure on Energy

The stock market reversed to go down as the Asian financial markets decreased yesterday.

At the close, the VNIndex lost 0.17% to close at 1,477 pts. Meanwhile, the trading volume was 942 million shares or VND28,798bn.

Foreign investors continued to net sell with a net value of VND15bn on HSX. They sold CII, HSG, and VIC the most with net values of VND131bn, VND41bn, and VND39bn, respectively.

Energy was the worst sectors driven by BSR (-3.56%), GAS (-2.32%), OIL (-2.35%), PLX (-2.39%), PVC (-2.68%), PVD (-3.78%), and PVS (-2.31%).

Selling pressure pushed Real Estate down, namely DXG (-1.93%), HDG (-2.63%), KBC (-1.75%), NDN (-3.06%), NLG (-3.55%), VHM (-1.18%), and VIC (-2.94%).

Some constituents of the VN30Index slid more than 1%, such as BVH (-1.74%), GVR (-1.70%), CTG (-1.52%), PNJ (-1.36%), MWG (-1.12%), and MBB (-1.06%).

In contrast, cash flowed into Brokerage thanks to SSI (+1.90%), VND (+6.50%), VCI (+2.27%), and HCM (+1.84%).

The VNIndex moves in a tight range in the short term, implying the market sentiment is still cautious. Besides, the 1,500-pts zone is the strong resistance for the VNIndex. Therefore, traders should wait for a breakout for 1,500-pts before opening their long positions.

Vietnam foreign flow

Foreign supply came back and fading the demand. Net sell value was USD90mn.

Foreign selling pressure has come back to Financials sector. Particularly, VPB, VCB, and SSI were sold the most, fading the solid demand on VND. Besides, Industrials and Materials continued to be divested due to large sell orders on HPG, GEX, and CII. On the contrary, Real Estate and Consumer Staples kept attracting foreign demand thanks to VIC, VRE, VHM, DGC, and VNM.

▶ South East Asia ETF flow

Money inflow ticked up across SEA. Net inflow was USD19mn, a monthly high. The positive flow of money was mainly driven by the surge of demand across major countries. Particularly, inflow has come back to Malaysia and Singapore after experiencing 4 consecutive weeks of outflow. Besides, Philippines kept attracting money inflow. However, Indonesia was strongly divested last week.



Vietnam has turned around to attract the positive flow of money. Inflow was USD2mn. Particularly, the positive flow of money was mainly contributed by the slowdown of divestment across VanEck Vietnam ETF. However, the positive flow among major ETFs was not significant, only attracted by VFMVN30 ETF. Thus, the flow of money was not diversified, implying the unstable flow of money.
