Volatile trading environment

VN30 performance

The VN30 index formed the closing price at 1,537 pts. Relating to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND435bn. Notably, foreign selling pressure focused on HPG, SSI, and MSN.

VN30 Future chart: The trend is held

VN30F2112 followed the downward swing, but there is no valid breakdown at 1,540 pts zone. Major short-term MAs continue to stay below the closing price (Daily chart), the uptrend is still active. With congestion zone, 1,540 pts zone turns around to act as the short-term benchmark for the uptrend whilst 1,580 pts zone is the last resistance for the upward resumption phase. Notably, the instrument is traded between major MAs, implying the increase of market noise. In this case, traders should hold the current long positions and avoid intraday trading.

Technical strategy

The captured long positions on VN30F2112 should not be closed and stop the loss when there is the closing price below 1,530 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




