Upward resumption phase

VN30 performance

The VN30 index formed the closing price at 1,550 pts. Relating to foreign trading activities, selling activities kept overwhelming with net sell value recorded at VND600bn. Notably, foreign selling pressure focused on VHM, VIC, and MSN.

VN30 Future chart: Uptrend is active

VN30F2112 positively reacted with 1,530 pts zone, confirming the upward resumption phase. Major short-term MAs continue to stay below the closing price (Daily chart), the uptrend is still active. With congestion zone, 1,530 pts zone acts as the short-term benchmark for the uptrend whilst 1,580 pts zone is the last resistance for the upward resumption phase. In this case, traders should hold the current long positions and there is the buying point for new positions.

Technical strategy

The captured long positions on VN30F2112 should not be closed and stop the loss when there is the closing price below 1,530 pts level (Hourly chart). For new positions, buy VN30F2112 after ATO session and stop the loss when there is the closing price below 1,530 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




