Wait for the valid entry point

VN30 performance

The VN30 index formed the closing price at 1,516 pts. Relating to foreign trading activities, buying activities came back with net buy value recorded at VND6.5bn. Notably, foreign demand focused on VIC, VHM, and VRE.

VN30 Future chart: Buy point is not ready

VN30F2112 consolidated on the previous trading day after forming the solid demand zone at 1,450 pts area. However, the instrument pierced major MAs on Daily chart and Hourly chart, the short-term correction phase still exists. With congestion zone, 1,450 pts zone will act as the significant short-term support zone. Notably, there is no valid entry due to the unclear upcoming movement.

Technical strategy

The short-term correction is still active. Traders should stay on the sidelines and wait for the valid entry point.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




