VN30 performance

The VN30 index formed the closing price at 1,530 pts. Relating to foreign trading activities, buying activities came back with net buy value recorded at VND190bn. Notably, foreign demand focused on VIC, VHM, and CTG.

VN30 Future chart: Pullback is needed for the valid uptrend

VN30F2112 kept following the upward swing and the correction phase is faded. Notably, the instrument closed above major MAs on Daily chart, confirming the valid upward move. With congestion zone, 1,450 pts zone will act as the significant short-term support zone whilst 1,580 will be the last barrier for the upward resumption phase. However, intraday pullback is needed in order to confirmed the higher low pattern where buy point will occur.

Technical strategy

The short-term correction is faded. However, intraday pullback is needed to validate the upward swing. Traders should stay on the sidelines and wait for the valid entry point.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




