# **Hold the long positions**

## **VN30** performance

The VN30 index formed the closing price at 1,535 pts. Relating to foreign trading activities, selling activity overwhelmed with net sell value recorded at VND3bn. Notably, foreign supply focused on MSN, CTG, and SSI.

## **VN30 Future chart: Uptrend is active**

VN30F2201 following the upward swing, confirming the valid breakout at 1,530 pts level. The instrument closed above major MAs, bullish momentum is improved and uptrend is active. With congestion zone, 1,480 pts zone will act as the important support whilst 1,580 pts area will be the next target for the upward resumption phase. In this case, traders should continue to hold the current long positions.

#### **Technical strategy**

The captured long on VN30F2201 should be held and stop the loss when there is the closing price below 1,500 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




