Consolidation phase

VN30 performance

The VN30 index formed the closing price at 1,532 pts. Relating to foreign trading activities, selling activity surged with net sell value recorded at VND570bn. Notably, foreign supply focused on VRE, VIC, and VNM.

VN30 Future chart: The uptrend is still active

VN30F2201 continued to consolidate on the previous trading day, but the uptrend is still held. Major MAs have confirmed the uptrend market thanks to its upward sloping. However, bullish momentum has shown some sign of weakness due to the violated MA20. With congestion zone, 1,530 pts zone has turned around to act as the important support whilst 1,580 pts area will be the last barrier for the upward resumption phase. As the uptrend is still active, traders could reenter the bullish swing when 1,530 pts zone is revisited.

Technical strategy

Long positions on VN30F2201 should not be closed and stop the loss when there is the closing price below 1,520 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




