Minor pullback

VN30 performance

The VN30 index formed the closing price at 1,526 pts. Relating to foreign trading activities, buying activity ticked up with net buy value recorded at VND80bn. Notably, foreign demand focused on KDH, VHM, and BID.

VN30 Future chart: The demand zone is positively reacted

Although VN30F2201 decreased slightly on the previous trading day, the bullish momentum is still maintained. However, the instrument is expected to enter the consolidation phase with the increase of volatility level due to the flat major MAs as well as narrowing Bollinger bands. With congestion zone, 1,480 pts is the important support whilst 1,580 pts area will be the last barrier for the upward resumption phase. In this case, traders should hold the current long positions and try to avoid intraday trading due to the surge of volatility level.

Technical strategy

Long positions on VN30F2201 should be held and stop the loss when there is the closing price below 1,500 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




