Respecting the demand zone

VN30 performance

The VN30 index formed the closing price at 1,532 pts. Relating to foreign trading activities, buying activity ticked up with net buy value recorded at VND50bn. Notably, foreign demand spread to VHM, PNJ, and TCB.

VN30 Future chart: The supply zone is still respected

VN30F2203 has respected 1,500 pts zone, fading the bearish swing, but the upward move is still dormant . With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). The bullish candle on the previous afternoon session has decreased the probability for the bearish swing to extend. For intraday movement, 1,500 is the benchmark. In this case, traders should hold the long positions and avoid intraday trading.

Technical strategy

Long position on VN30F2203 should be held and stop the loss when there is the closing price below 1,500 pts level.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




