Inflow comes back to normal level

Vietnam foreign flow

Foreign selling activity was completely faded. Net buy value was USD85mn, a 6-month high.

Foreign demand spread to major sectors, such as Financials and Real Estate. Particularly, buying activity mainly focused on CTG, STB, VND, VHM, KBC, and VRE. Besides, Industrials also attracted foreign demand thanks to GEX. On the contrary, foreign selling activity kept focusing on Consumer Staples and Materials, driven by the strong divestment on MSN, VNM, SAB, and HPG. Besides, foreign selling pressure also spread to Energy due to large sell orders on PLX.

South East Asia ETF flow

Inflow was maintained across SEA. Net inflow was USD26mn, down 70% WoW. The slowdown of inflow was mainly driven by the drop of inflow via major ETFs of Vietnam.

Inflow across Vietnam dropped on the last trading week of 2021. Net inflow was USD4mn. Particularly, major ETFs experienced the divestment, such as VFMVN30 ETF and X FTSE. However, the outflow was fully covered by the strong demand on Fubon FTSE. In accumulated 6M, major ETFs such as VFMVN Diamond, Fubon FTSE, VanEck, and FTSE were still divested, implying the unstable flow of money across Vietnam via major ETFs.





Figure 3. Net buy/sell by sector, 14-28 Jan




Figure 4. Foreign holding by sector






Figure 5. Weekly ETF net flow to SEA




