Market commentary

A crash again?

The stock market resumed to go down yesterday due to selling pressure on key tickers.

At the close, the VNIndex lost 1.02% to close at 1,483 pts. Meanwhile, the trading volume was 1,034 million shares or VND32,844bn.

Foreign investors continued to net sell with a net value of VND85bn on HSX. They sold VNM, VCI, and DHC the most with net values of VND104bn, VND50bn, and VND39n, respectively.

Real Estate was the worst sector driven by CEO (-7.04%), DIG (-6.96%), DXG (-1.72%), FLC (-6.85%), HDG (-2.19%), KBC (-2.42%), NLG (-4.43%), NVL (-1.32%), VHM (-3.12%), and VRE (-2.14%).

Moreover, Financial underperformed the benchmark index due to BID (-4.26%), STB (-5.35%), VPB (-1.36%), CTG (-1.24%), HCM (-3.41%), SSI (-2.76%), VDS (-4.38%), and VND (-2.89%).

Some constituents of the VN30Index slid more than 1%, such as GVR (-2.45%), VNM (-2.39%), VJC (-1.54%), and HPG (-1.08%).

In contrast, cash flowed into Energy thanks to PVS (+4.64%), BSR (+1.12%), PVD (+1.84%), PVT (+1.56%), and PVC (+3.81%).

Based on the strong bearish session, the downside risk is still intact as the selling pressure appears at the 1,510-pts threshold. Therefore, traders should still be careful and stay on the sidelines.

▶ Vietnam: FitchRatings to affirms Vietnam's credit rating at "BB" with positive outlook

On March 28th, FitchRatings agency has released the latest update for Vietnam's economic outlook and the credit assessment in the medium-term period. Specifically, the agency forecasted Vietnam's economy to accelerate growth to 6.1% in 2022 and 6.3% in 2023 from its pandemic-caused bottom of 2.6% in 2021, reflecting a recovery from domestic consumption, strong export, and high FDI inflows into the manufacturing sector. In the downward scenario of the economy due to a slowdown in the global economy, implications from the Russia - Ukraine war, higher commodities prices, and further pandemic-related shocks, Fitch is projecting Vietnam's economic growth at 3.5% in 2022 from 4.2% in the previous update. Besides, with strong foreign reserve buffers (foreign reserves up to USD109.4bn at end-2021) and the expectation of current account surpluses in 2022, the exchange rate is expected to gradually appreciate in the year.
