Rigid price movement

VN30 performance

The VN30 index formed the closing price at 1,520 pts. Relating to foreign trading activities, selling activity ticked up with net sell value recorded at VND390bn. Notably, foreign supply spread to HPG, VIC, and HDB.

VN30 Future chart: All eyes on 1,500 pts zone

VN30F2203 has continued to follow the rigid price movement and trading signal is still unclear. Trading volume has started to drop, implying the decrease of trading activity as well as market is on the fence. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). For intraday movement, 1,500 is the benchmark. In this case, traders should hold the long positions and avoid intraday trading due to the increase of volatility level.

Technical strategy

Long position on VN30F2203 should be held and stop the loss when there is the closing price below 1,500 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




