# **Downtrend** is active

## **VN30** performance

The VN30 index formed the closing price at 1,498 pts. Relating to foreign trading activities, selling activity ticked up with net sell value recorded at VND390bn. Notably, foreign supply spread to HPG, VIC, and HDB.

### **VN30 Future chart: Downtrend is ready**

VN30F2203 dropped on the previous trading day and confirming the downtrend. The instrument closed below major MAs, implying the increase of bearish momentum and the bearish swing is active. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). For intraday movement, 1,485 pts area is the short-term target for the downward swing. In this case, traders should liquidate all the long positions and stay on the sidelines.

### **Technical strategy**

Long position on VN30F2203 need to be closed after ATO session. Traders should stay on the sidelines in order to wait for the better entry point for short position.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




