# Positive reaction at 1,500 pts zone

## **VN30** performance

The VN30 index formed the closing price at 1,522 pts. Relating to foreign trading activities, buying activity ticked up with net buy value recorded at VND160bn. Notably, foreign demand spread to HPG, STB, and MSN.

#### VN30 Future chart: Positive reaction at 1,500 pts zone

VN30F2203 has entered the rebound phase after positively reacting with 1,500 pts zone. The instrument turned around to close above major MAs, implying the weakness of bearish momentum. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). For intraday movement, 1,500 pts area is the demand zone, followed by 1,485 pts area.

### **Technical strategy**

VN30F2203 has entered the rebound phase, but bearish momentum is still active near 1,520 pts zone. Thus, traders should stay on the sidelines and wait for the valid trading signal.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




