# **Intraday consolidation phase**

## **VN30 performance**

The VN30 index formed the closing price at 1,469 pts. Relating to foreign trading activities, selling activity ticked up with net sell value recorded at VND680bn. Notably, foreign supply spread to HPG, MSN, and VIC.

# VN30 Future chart: Downtrend is active

VN30F2203 could not break 1,460 pts zone, but the trend is still downward. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). However, there is no sign for the weakness of bearish momentum. The broken 1,500 pts area has turned around to act as the short-term resistance whilst 1,460 pts zone is expected to be the intraday demand zone. In this case, traders should stay on the sidelines and new short position should be opened when the rebound phase occurs.

# **Technical strategy**

Although there is the intraday rebound, the trend is still downward. Traders should continue to stay on the sidelines and new short position should be opened later.



#### Figure 1. VN30 Generics hourly chart





#### Figure 4. Open interest pattern






#### Figure 3. Future price curve
