# **Correction still remains**

## **VN30** performance

The VN30 index formed the closing price at 1,477 pts. Relating to foreign trading activities, selling activity remained at high level with net sell value recorded at VND350bn. Notably, foreign supply spread to MSN, VNM, and VIC.

### VN30 Future chart: The trend is still downward

VN30F2204 continued to follow the short-term rebound phase thanks to the respected 1,460 pts zone, but volatility level would surge due to the current short-term downtrend. With congestion zone, 1,450 pts zone and 1,550 pts zone are the range demand and supply area (Daily chart). Although there is the rebound phase, the trend is still downward and the intraday bullish swing could not extend. The broken 1,500 pts area keepts acting as the short-term resistance whilst 1,460 pts zone is expected to be the benchmark for the rebound phase. In this case, traders should stay on the sidelines and repair to open short positions.

## **Technical strategy**

Although there is the downtrend, but rebound phase is still active. Traders should continue to stay on the sidelines and wait for accurate trading signal.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




