VN30 performance

The VN30 index formed the closing price at 1,484 pts. Relating to foreign trading activities, selling pressure ticked up with net sell value recorded at VND90bn. Notably, foreign supply spread to VNM, VIC, and CTG.

VN30 Future chart: Keep forming the lower high

VN30F2204 has experienced the surge of bearish momentum, forming the higher low and the downward swing has high probability to extend. The bullish momentum of the previous rebound phase was completely faded. Notably, major MAs on Daily chart are still sloping downward, the correction phase still remains. The 1,500 pts area keeps acting as the short-term resistance whilst 1,460 pts zone is expected to be the benchmark for the rebound phase.

Technical strategy

VN30F2204 is having the tendency to retest the 1,460 pts area. Traders should continue to stay on the sidelines and wait for accurate trading signal due to the increase of volatility level in upcoming sessions.



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




