Vietnam is strongly divested

Vietnam foreign flow

Foreign selling activity surged. Net sell value was USD230mn.

Foreign selling pressure kept focusing on Real Estate and Materials due to the solid supply on VHM, NVL, VIC, and HPG. Notably, Consumer Staples and Financials turned around to be net sold thanks to the strong divestment on HDB, MSN and VNM. Industrials and Utilities were also negatively impacted by the solid sellind pressure due to large sell orders on GMD and GAS.

South East Asia ETF flow

Inflow was maintained across SEA, but the positive flow of money has slowed down. Net inflow was USD36mn. The drop of money inflow was mainly driven by the strong outflow across Vietnam. However, the outflow of Vietnam was totally faded by the strong demand across major SEA's countries, such as Thailand and Philippines. Besides, Singapore, Malaysia, and Indonesia continued to attract the positive flow of money.

Vietnam experienced the strong divestment. Net outflow was USD29mn, a 6-month high. Outflow has spread to major ETFs. Particularly, VFMVN30 ETF and VanEck experienced the divestment. Notably, outflow has come back to VFMVN Diamond, recorded at USD11mn.





Figure 3. Net buy/sell by sector, 07-11 Mar











Figure 5. Weekly ETF net flow to SEA





Figure 7. ETF focus by sector





Figure 9. Vietnam ETF net flow (6M accumulated)




