Solid demand zone is tested

VN30 performance

The VN30 index formed the closing price at 1,507 pts. Relating to foreign trading activities, supply ticked up with net sell value recorded at VND345bn. Notably, foreign supply spread to MSN, VHM, and VIC.

VN30 Future chart: Testing the solid demand zone

VN30F2204 kept facing the selling pressure, testing the important support zone - 1,500 pts zone. If the 1,500 pts zone is broken, the benchmark for the upward swing – 1,470 pts zone will be the next target. If 1,500 pts is respected after the pullback, the upward swing is solid. In this case, traders could open the long positions on the pullback when there is the positive reaction at 1,500 pts zone.

Technical strategy

Long position on VN30F2204 should be held. However, the loss should be stopped when there is the closing price below 1,475 pts level. For new long positions, traders could wait for the positive reaction at 1,500 pts zone to validate the trading signal. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




