VN30 performance

The VN30 index formed the closing price at 1,518 pts. Relating to foreign trading activities, supply ticked up with net sell value recorded at VND345bn. Notably, foreign supply spread to MSN, VHM, and VIC.

VN30 Future chart: Testing the solid demand zone

VN30F2204 has entered the volatile trading zone due to the balance stage between demand and supply. If the 1,500 pts zone is held, the upward swing is more valid. The selling pressure above remains but bearish swing has low probability to extexd. In this case, traders could hold the current long positions and wait for the valid buy point, which comes after the volatile environment.

Technical strategy

Long position on VN30F2204 should be held. However, the loss should be stopped when there is the closing price below 1,475 pts level. For new long positions, traders could wait for the valid buy point. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




