Keep testing the support zone

VN30 performance

The VN30 index formed the closing price at 1,493 pts. Relating to foreign trading activities, supply ticked up with net sell value recorded at VND65bn. Notably, foreign supply spread to HPG, SSI, and TPB.

VN30 Future chart: The upcoming move is unclear

VN30F2204 has faced the selling pressure at the all-time high zone, creating the pullback, but there is no positive reaction at 1,500 pts zone. The 1,500 pts area acts as the significant demand zone, followed by the benchmark for the upward swing - 1,470 pts zone. However, demand is still low near 1,500 pts area, increasing the tendency for this instrument to retest 1,470 pts zone. In this case, traders should continue to hold the current long position due to the unclear bearish signal.

Technical strategy

Long position on VN30F2204 should be held. However, the loss should be stopped when there is the closing price below 1,475 pts level. (Hourly chart)





Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




