Market commentary

Resume uptrend

The stock market maintained its uptrend yesterday thanks to high demand on some key tickers.

At the close, the VNIndex gained 1.01% to close at 1,240 pts. Meanwhile, the trading volume was 537 million shares or VND13,825bn.

Foreign investors reversed to net buy with a net value of VND180bn on HSX. They purchased GAS, VNM, and KBC the most, with net values of VND57bn, VND43bn, and VND37bn, respectively.

Brokerage was the market leader driven by BSI (+0.87%), BVS (+2.02%), HCM (+1.33%), VCI (+6.93%), and VND (+2.27%).

Cash flowed into Banking and Energy, namely BID (+1.31%), CTG (+1.33%), LPB (+5.71%), MBB (+1.33%), TCB (+3.44%), BSR (+4.83%), GAS (+4.06%), and PVD (+1.89%).

Some constituents of the VN30Index jumped more than 1% driven by MSN (+6.94%) and MWG (+1.44%).

In contrast, TPB (-2.42%), SAB (-2.42%), PDR (-2.11%), and FPT (-2.01%) closed in red territory.

Despite the bullish trend, the liquidity is still low level, implying the bullish trend is not confirmed. Therefore, traders should wait for the next signals and stay on the sidelines.
