Demand ticks up near 1,350 pts zone

VN30 performance

The VN30 index formed the closing price at 1,405 pts. Relating to foreign trading activities, supply outweighted demand with net sell value recorded at VND96bn. Notably, foreign selling pressure spread to KDH, GAS, and VCB.

VN30 Future chart: Demand ticks up

VN30F2205 has attracted the solid demand near 1,350 pts area, forming the higher low and increasing the probability for the rebound phase to extend. Particularly, 1,450 pts area acts as the barrier for the rebound phase. On the downside, 1,350 pts zone is the benchmark for the rebound phase. As the bullish pattern is formed, traders could open the long position. However, the main trend is still downward, profit should be taken near 1,450 pts zone.

Technical strategy

Long VN30F2205 after ATO session, take profit near 1,450 pts level and stop the loss when there is the closing price below 1,370 ptz level.



Figure 4. Open interest pattern








Figure 3. Future price curve
