# **Bullish pattern is faded**

#### **VN30** performance

The VN30 index formed the closing price at 1,373 pts. Relating to foreign trading activities, supply outweighted demand with net sell value recorded at VND67bn (weekly). Notably, foreign selling pressure spread to VCB, VNM, and NVL.

## VN30 Future chart: Bullish pattern is faded

VN30F2205 dropped on the previous trading day, fading the bullish pattern due to the weakness of demand. Particularly, 1,400 pts area acts as the barrier for the rebound phase. On the downside, 1,350 pts zone is the benchmark for the rebound phase. If this area is broken, 1,300 pts is the next destination. As the bullish pattern is faded and the 1,350 pts area is still held, traders should stay on the sidelines and wait for the next accurate trading signal.

## **Technical strategy**

As the bullish pattern is faded and VN30F2205 is testing the demand zone (1,350 pts zone). Traders should stay on the sidelines and wait for the next accurate trading signal.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




