## Selling pressure is still strong

### **VN30** performance

The VN30 index formed the closing price at 1,255 pts. Relating to foreign trading activities, supply kept overwhelming with net sell value recorded at VND470bn. Notably, foreign selling pressure spread to HPG, SSI, and VIC.

# VN30 Future chart: Selling pressure at 1,300 pts zone is strong

VN30F2205 decreased due to the strong selling pressure near 1,300 pts area. However, the instrument is expected to fluctuate within 1,200-1,300 pts zone due to the low probability for piercing 1,200 pts level. As major MAs are sloping downward, the bearish market is still not faded. Notably, consolidation is needed in order to accumulate demand. Traders should continue to stay on the sidelines and wait for the next accurate trading signal which would come after the consolidation phase.

## **Technical strategy**

The instrument is expected to fluctuate within 1,200-1,300 pts zone due to the low probability for piercing 1,200 pts level. Thus, traders should continue to stay on the sidelines and wait for the next accurate trading signal which would come after the consolidation/fluctuation phase.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




