

Rebound phase has high probability to extend

VN30 performance

The VN30 index formed the closing price at 1,335 pts. Relating to foreign trading, demand ticked up with net buy value recorded at VND280bn. Notably, foreign demand spread to VHM, HPG, and MSN.

VN30 Future chart: Rebound phase would be extended

VN30F2206 has entered the intraday consolidation phase but demand has remained near 1,300 pts zone. As major MAs are pierced, the bearish market is temporary faded and bullish momentum is outperforming in the short-term. The broken 1,300 pts zone has turned around to act as the intraday demand zone, followed by 1,250 pts area. As bullish momentum is improved, the rebound phase has high probability to extend. In this case, traders could hold the current long positions.

Technical strategy

Long position on VN30F2206 should be held and stop the loss when there is the closing price below 1,270 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




