VN30 performance

The VN30 index formed the closing price at 1,324 pts. Relating to foreign trading, demand came back with net buy value recorded at VND17bn. Notably, foreign demand spread to PNJ, MSN, and HPG.

VN30 Future chart: High fluctuation period

VN30F2206 has entered the volatile trading zone, retesting the 1,300 pts area. However, there is demand near this area. Major short-term MAs are pierced on Daily chart, the bearish market is temporary faded and bullish momentum is outperforming in the short-term. Notably, narrow spread candle occurred on Daily chart, implying the existence of fluctuation trading period. The broken 1,300 pts zone has turned around to act as the intraday demand zone, followed by 1,250 pts area. Although there is the rebound phase, the main trend is still downward. If 1,300 pts zone is broken, the short-term bullish momentum would be faded. In this case, traders could hold the current long position.

Technical strategy

Long position on VN30F2206 should be held and stop the loss when there is the closing price below 1,270 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




