VN30 performance

The VN30 index formed the closing price at 1,325 pts. Relating to foreign trading, demand came back with net buy value recorded at VND17bn. Notably, foreign demand spread to PNJ, MSN, and HPG.

VN30 Future chart: Fluctuation period still exists

VN30F2206 dropped on the previous trading day but the trading zone (1,300-1,340 pts area) is still respected. Major short-term MAs are pierced on Daily chart, the bearish market is temporary faded and bullish momentum is outperforming in the short-term. However, the selling pressure above is still strong as well as 1,300 pts level is still held which mean the fluctuation period still exists. Although there is the rebound phase, selling pressure near 1,350 pts zone is still active. In this case, traders could hold the current long position.



Figure 1. VN30 Generics hourly chart






Figure 4. Open interest pattern


