Second consolidation session?

The stock market resumed its downtrend because profit-taking appeared in the afternoon.

At the close, the VNIndex lost 0.23% to close at 1,176 pts. Meanwhile, trading volume was 492 million shares/VND11,218bn, down 6%/ 2% respectively, from the previous week's average.

Foreign investors reversed to net sell with a net value of VND115bn on HSX. They sold VHM, HPG, and DXG the most, with net values of VND44bn, VND44bn, and VND27bn, respectively.

Selling pressure pushed Real Estate down, namely CEO (-2.96%), DXG (-2.51%), HDG (-0.89%), KDH (-0.41%), NLG (-1.05%), VHM (-1.67%), VIC (-2.30%), and VRE (-0.57%).

Some constituents of the VN30Index slid more than 1% such as HPG (-2.59%) and STB (-1.96%).

In contrast, cash flowed into Energy thanks to BSR (+3.06%), OIL (+3.25%), PLX (+1.13%), POW (+0.77%), and PVD (+0.89%).

The downtrend is dominant in the short term. Therefore, traders should stay on the sidelines and wait for the next signal.
