#### **Consolidation phase?**

The stock market reversed to go down due to profit-taking on large-cap stocks.

At the close, the VNIndex lost 0.31% to close at 1,194 pts.

Finance was the worst sector due to ACB (-1.22%), BID (-2.74%), CTG (-2.18%), HDB (-1.04%), TPB (-0.88%), HCM (-2.57%), SSI (-1.88%), and VND (-1.04%).

Selling pressure pushed Real Estate down namely CEO (-3.15%), DXG (-1.35%), KDH (-1.22%), NLG (-1.44%), PDR (-1.32%), VIC (-2.92%), and VRE (-1.14%).

Some constituents of the VN30Index slid more than 1% such as HPG (-2.20%), VNM (-1.64%), POW (-1.50%), and PLX (-1.30%).

In contrast, GAS (+3.55%), MSN (+2.84%), MWG (+0.62%), and SAB (+0.61%) closed in green territory.

Because of selling pressure at the high level, the downtrend is still dominant in the short term. Therefore, traders should stay on the sidelines and wait for the next signal.

▶ Market performance

The VNIndex continued to go up last week for two gaining weeks in a row.

▶ Chart: Support at 1,150-pts zone

The index crosses the 10-period and 20-period moving averages going up. In addition, the MACD increases and is above its signal line. That means the buying signals in the short term.

However, the liquidity is low level, showing caution from buyers and sellers. Besides, the index closes below the long- and medium moving average. That implies the downtrend is dominated.

The 1,150 pts of zone acts as the significant demand zone for the upward swing.

- → Although some bullish signals appear, the downtrend is dominant in the short term. Hence, we need more confirmation signals to define a new uptrend.
- ▶ Technical strategy: Stay on the sidelines

Based on a selling pressure on a high level, traders should be careful about the bull trap, stay on the sidelines and wait for the next signals.
