VN30 performance

The VN30 index formed the closing price at 1,222 pts. Relating to foreign trading, demand ticked up with net buy value recorded at VND105bn. Notably, foreign buying activity spread to SSI, GAS, and VHM.

VN30 Future chart: Approaching the solid selling zone

VN30F2208 decreased slightly on the previous trading day after approaching the solid selling zone (1,220-1,230 pts area). However, major MAs continue to support the bearish swing and selling pressure is still maintained. 1,220 pts zone is pierced, higher low and higher high pattern was formed and the rebound phase has high probability to extend. Notably, OI (Open Interest) ticked up, implying the trending market. In this case, traders should capture the long position on pullback.

Technical strategy

Long VN30F2208 near 1,220-1,225 pts area and stop the loss when there is the closing price below 1,215 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




