Rebound phase keep extending

VN30 performance

The VN30 index formed the closing price at 1,256 pts. Relating to foreign trading, demand ticked up with net buy value recorded at VND560bn. Notably, foreign buying activity spread to SSI, STB, and HPG.

VN30 Future chart: Heading to 1,260 pts area

VN30F2208 kept following the rebound phase, approaching the solid selling zone 1,240 pts area with the stable bullish momentum. However, major MAs are on the fence which means the reversal is not completely formed. Notably, OI (Open Interest) has started to increase, the bullish swing is validated. In this case, traders should tighten the current stop loss level for the captured long positions.

Technical strategy

Long position on VN30F2208 near 1,220-1,225 pts area should be held and stop the loss when there is the closing price below 1,215 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




