VN30 Future Daily 4 Aug 2022

Stable bullish momentum

VN30 performance

The VN30 index formed the closing price at 1,270 pts. Relating to foreign trading, demand ticked up with net buy value recorded at VND645bn. Notably, foreign buying activity spread to SSI, HPG, and VHM.

VN30 Future chart: Heading to 1,260 pts area

VN30F2208 kept following the rebound phase, increasing the tendency to retest 1,250-1,260 pts zone. However, on Daily chart, major MAs are on the fence which means the reversal is not completely formed. OI (Open Interest) increased strongly, the bullish view is still active and the bullish swing has high probability to extend. However, VN30F2208 is trading 20 pts below its underlying – VN30 Index which implies the surge in volatility level in upcoming sessions. In this case, traders should tighten the current stop loss level for the captured long positions.

Technical strategy

Long position on VN30F2208 near 1,220-1,225 pts area should be held and stop the loss when there is the closing price below 1,215 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




