VN30 Future Daily 10 Aug 2022

Bullish momentum is still stable

VN30 performance

The VN30 index formed the closing price at 1,273 pts. Relating to foreign trading, selling pressure kept overwhelming with net sell value recorded at VND120bn. Notably, foreign selling activity spread to HPG, VNM, and MSN.

VN30 Future chart: Heading to 1,260 pts area

VN30F2208 kept following the rebound phase, approaching the 1,260-1,280 pts zone and bullish momentum keeps showing no sign of weakness. However, on Daily chart, major MAs are still on the fence which means minor pullback is needed to sustain the rebound period. OI (Open Interest) increased strongly, the bullish swing is still active and this swing has high probability to extend on upcoming sessions. However, spread between VN30F2208 and its underlying – VN30 Index is still wide which implies the potential increase in volatility level. In this case, traders should tighten the current stop loss level for the captured long positions.

Technical strategy

Long position on VN30F2208 near 1,220-1,225 pts area should be held and stop the loss when there is the closing price below 1,215 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




