#### **Market commentary Hieu Tran** hieu.ttm@kisvn.vn **Bottom fishing**

Bottom fishing made the loss of the VNIndex to be narrow yesterday, however, the stock market maintained its downtrend.

At the close, the VNIndex lost 0.61% to close at 1,240 pts. Meanwhile, trading volume was 581 million shares/VND14,339bn, down 2%/6% respectively, from the previous week's average.

Foreign investors continued to net sell with a net value of VND52bn on HSX. They sold VHM, STB, and KBC the most, with net values of VND52bn, VND39bn, and VND38bn, respectively.

Banking was the worst sector driven by ACB (-1.26%), BID (-0.82%), CTG (-1.82%), HDB (-2.70%), MBB (-0.67%), TCB (-1.34%), TPB (-1.12%), and VPB (-0.66%).

Some constituents of the VN30Index slid more than 2% such as SAB (-3.66%), and VNM (-2.25%).

In contrast, Brokerage outperformed the benchmark index, namely BSI (+1.82%), HCM (+5.84%), SSI (+1.39%), VCI (+3.08%), and VND (+0.76%).

The VNIndex decreases after retesting the 1,250-pts threshold, implying a short-term downtrend. Therefore, traders should reduce long positions and wait for the next signals.
