Trading point will occur if range bound is broken

VN30 performance

The VN30 index formed the closing price at 1,301 pts. Relating to foreign trading, foreign investors continued to net sell with a net value of VND162bn on HSX. They sold DGC, SSI, and HPG the most.

VN30 Future chart: The range is still held

VN30F2209 kept following the range bound movement with upper and lower threshold are 1,300 pts and 1,250 pts area, respectively. Notably, 1,250 pts area is the benchmark for the rebound phase. If this zone is broken, rebound phase is faded. On the upside, 1,300 pts area is the congestion zone for the rebound phase. If breakout occurs at this zone, 1,400 pts area is the next destination. On Daily chart, major MAs confirm the bear market rally. OI (Open Interest) kept decreasing, market swing has been paused and range bound would remain on upcoming session. In this case, traders should stay on the sidelines and wait for accurate trading point.

Technical strategy

Although VN30F2209 has attracted buying activity near the demand zone, buy point is still not confirmed due to the existing range bound. In this case, traders should stay on the sidelines and wait for accurate trading point which would occur after the consolidation phase.



Figure 4. Open interest pattern








Figure 3. Future price curve
