Market commentary

Bullish signals

The stock market rebounded yesterday because bottom fishing appears when the VNIndex opened below the 900-pts threshold.

At the close, the VNIndex jumped 3.40% to close at 942 pts. Meanwhile, trading volume was 994 million shares/VND14,371bn, up 59%/ 36% respectively, from the previous week's average.

Foreign investors resumed to net buy with a net value of VND657bn on HSX. They purchased CTG, FUEVFVND, and VHM the most, with net values of VND94bn, VND66bn, and VND58bn, respectively.

Banking was the market leader driven by CTG (+5.98%), HDB (+6.43%), MSB (+5.91%), TPB (+4.77%), and VPB (+5.80%). Notably, ACB, BID, LPB, MBB, SHB, STB, and TCB were up by the daily limit.

Energy and Brokerage outperformed the benchmark index thanks to BSR (+5.17%), GAS (4.93%), PLX (+5.48%), POW (+5.43%), PVD (+6.67%), SSI (+6.83%), and VND (+6.57%).

Some constituents of the VN30Index jumped more than 6% such as GVR (+7.00%), MWG (+6.87%), HPG (+6.80%), BVH (+6.77%), and VRE (+6.41%).

Despite the recovery, the downtrend is dominant in the short term as the VNIndex retests the 900-pts threshold. Therefore, traders should stay on the sideline and wait for the next signals.
