Selling pressure at 1,050 pts area

VN30 performance

The VN30 index formed the closing price at 1,038 pts. Banking was the market leader driven by HDB (+1.22%), MBB (+1.69%), MSB (+2.02%), STB (+4.64%), TCB (+4.27%), VCB (+2.04%), VIB (+2.81%), and VPB (+5.20%).

VN30 Future chart: Selling pressure at 1,050 pts area

The rebound phase on VN30F2211 is confirmed thanks to the higher low pattern. As the major MAs are pierced on Hourly chart, the bearish momentum is temporary faded. However, bearish swing is still active due to the unbroken 1,050 pts area. The bearish swing would be completely paused only when 1,050 pts area is pierced. Notably, total OI (Open interest) stayed above 45,000 contracts, implying the active market swing and consolidation phase is dormant. Besides, volatility level in upcoming session would be increased due to the wide spread between VN30F2211 and VN30 Index. In this case, traders should hold the captured long positions.

Technical strategy

Long VN30F2211 after ATO session, set 1,080 pts area as the profit target and stop the loss when there is the closing price below 1,000 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




