Entering the selling zone

VN30 performance

The VN30 index formed the closing price at 963 pts. Brokerage was the market leader driven by SSI (\pm 2.85%), SHS (\pm 9.37%), HCM (\pm 5.11%), FTS (\pm 6.95%), and BVS (\pm 2.21%).

VN30 Future chart: Selling pressure at 1,000 pts area

The rebound phase has been active on VN30F2212 thanks to the massive demand near 850 pts area. However, as higher low is not confirmed, the instrument has high probability to enter the short-term consolidation phase and the rebound phase is still weak. Bearish swing still exists due to the unbroken 1,050 pts area. If this area is broken, the bearish swing would be completely paused. Notably, total OI (Open interest) stayed below 50,000 contracts, implying the inactive market swing and range bound could occur in upcoming session. In this case, traders should open the long positions but position size should be small.

Technical strategy


Buy VN30F2212 after ATO session and stop the loss when there is the closing price below 930 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




