Market commentary

Optimistic market sentiment

The stock market maintained its uptrend after the VNIndex confirmed the bullish trend two days ago.

At the close, the VNIndex gained 1.58% to close at 1,048 pts. Meanwhile, trading volume was 1,104 million shares/VND17,760bn, up 72%/ 72% respectively, from the previous week's average.

Foreign investors continued to net buy with a net value of VND1,656bn on HSX. They purchased HPG, VHM and FUEVFVND the most, with net values of VND467bn, VND252bn, and VND157bn, respectively.

Real Estate was the market leader driven by KBC (+4.70%), NLG (+3.26%), and VHM (+2.64%). Notably, CEO, DXG, HDG, KDH, NVL, and PDR were up by the daily limit.

Energy and Brokerage outperformed the benchmark index namely BSR (+3.50%), OIL (+3.80%), PVC (+4.80%), PVD (+3.27%), SSI (+1.58%), VCI (+5.82%), and VND (+6.25%).

Some constituents of the VN30Index jumped more than 4% such as VIB (+6.86%), HPG (+5.75%), and VPB (+4.02%).

In contrast, GAS (-1.61%), CTG (-0.55%), and PLX (-0.34%) closed in red territory.

The VNIndex confirms the short-term uptrend thanks to the fifth gaining session. That means a short-term uptrend. Therefore, traders may open a long position on leading stocks with small sizes.
