Market commentary

Profit-taking on Banking

The stock market reversed to go down due to selling pressure on Banking stocks after SBV allowed to increase in credit room.

At the close, the VNIndex lost 4.11% to close at 1,048 pts. Meanwhile, trading volume was 1,428 million shares/VND23,519bn, up 30%/ 28% respectively, from the previous week's average.

Foreign investors continued to net buy with a net value of VND782bn on HSX. They purchased SSI, VHM, and FUEVFVND the most, with net values of VND151bn, VND134bn, and VND97bn, respectively.

Banking was the worst sector due to ACB (-5.51%), BID (-5.21%), CTG (-5.59%), MSB (-5.38%), TCB (-6.72%), TPB (-6.70%), and VCB (-5.88%). Notably, MBB, SHB, STB, VIB, and VPB were down by the daily limit.

Selling pressure pushed Energy and Brokerage down, namely BSR (-8.28%), PLX (-5.77%), POW (-5.22%), PVC (-5.04%), SSI (-6.01%), VCI (-6.88%), and VDS (-6.92%).

Some constituents of the VN30Index slid more than 6% such as HPG (-7.00%), NVL (-7.00%), VRE (-6.97%), PDR (-6.91%), MWG (-6.83%), and GVR (-6.73%).

In contrast, HAG (+6.97%), HNG (+6.81%), IDI (+6.76%), DCM (+4.34%), and DBC (+4.23%) closed in green territory.

Based on the sharp contract, the market trend become negative. If the VNIndex closes below the 1,000-pts threshold, the bearish market will return. Therefore, traders should wait for the next signals before investment decisions.
