### **Market commentary**

### **Bull trap?**

The stock market reversed to go up thanks to high demand on Real Estate.

At the close, the VNIndex gained by 0.91% to close at 1,032 pts.

Banking was the market leader driven by CEO (+2.44%), DIG (+2.99%), DXG (+4.05%), KBC (+1.37%), KDH (+1.75%), NLG (+1.32%), VHM (+6.70%), and VRE (+1.55%).

Some constituents of the VN30Index jumped more than 2% such as VPB (+3.30%), POW (+2.72%), SSI (+2.56%), and HPG (+2.25%).

In contrast, HDB (-2.25%), PLX (-1.98%), MSN (-1.72%), VJC (-1.70%), PDR (-1.69%), and SAB (-1.59%) closed in red territory.

Despite the recovery, the VNIndex closes below the significant moving averages, showing a downtrend in the short term. Therefore, traders should stay on the sidelines.
