

Bullish momentum is still weak

VN30 performance

The VN30 index formed the closing price at 1,056 pts. Relating to foreign trading activity, demand came back to high level with net buy value was VND110bn, mainly driven by large buy orders on VHM, HPG, and SSI.

VN30 Future chart: Bearish swing is still active

Bearish swing is paused on VN30F2304 due to the increase of demand near 1,000 pts zone. Although there is the rebound, demand is still weak and flat movement is still active in order to accumulate more demand. If the 1,000 pts area is broken, 900 pts zone would be the next destination. The rebound phase will be completely active if the 1,100 pts zone is broken. Bearish swing is still active due to the unformed higher high pattern. With short-term movement, the instrument still follows the flat period with unclear trend. Notably, total OI (Open interest) came back to above 50,000 contracts, implying the high probability for the upcoming market leg which would end the current consolidation phase, but trading signal is still unclear. In this case, traders could stay on the sidelines and wait for the accurate market swing and capture the trading point later.

Technical strategy

With short-term movement, the instrument still follows the flat period with unclear trend which is defined as the risky trading environment. Traders should stay on the sidelines and wait for the accurate market swing and capture the trading point later. (Hourly chart)

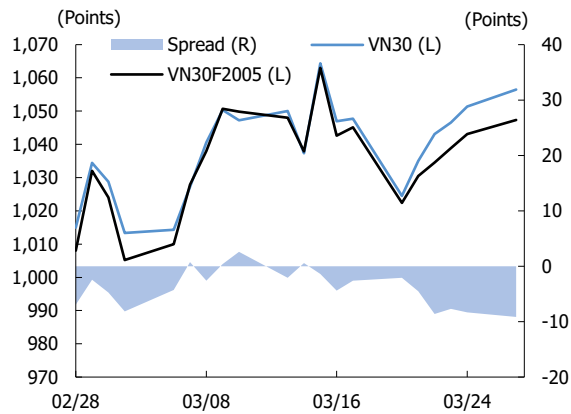

Figure 1. VN30 Generics hourly chart



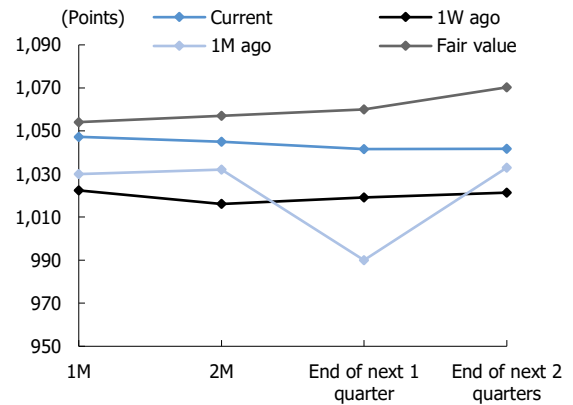

Figure 2. Basis spread



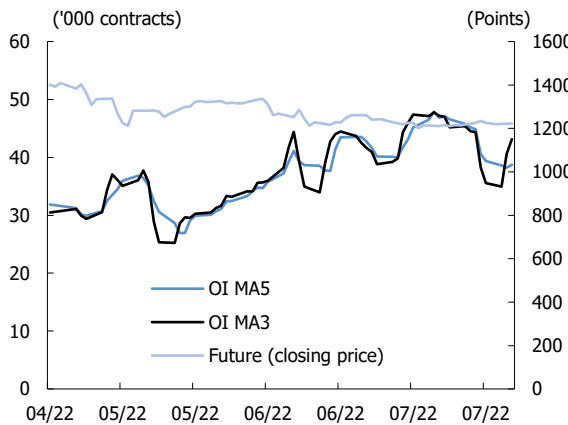

Figure 3. Future price curve



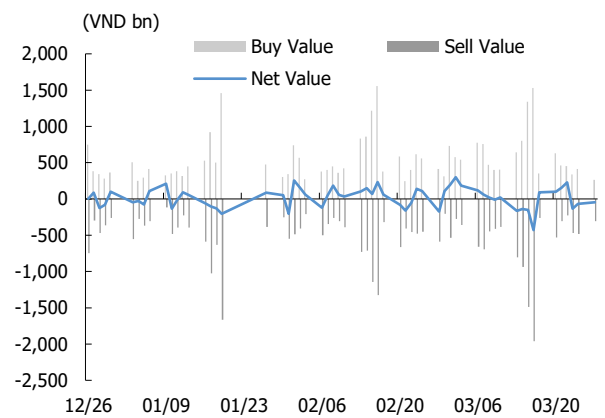
