Market commentary

High selling pressure

The stock market resumed going down last Friday due to high selling pressure in the afternoon session.

At the close, the VNIndex lost 0.60% to close at 1,042 pts.

Energy was the worst sector due to BSR (-1.88), GAS (-0.62%), POW (-2.66%), PVB (-0.73%), PVD (-0.98%), PVS (-1.58%), and PVT (-1.73%).

Some constituents of the VN30Index slid more than 1% such as NVL (-5.56%), PDR (-2.99%), MWG (-2.72%), HDB (-2.08%), MSN (-2.05%), and VJC (-2.01%).

In contrast, cash flowed into Brokerage, namely HCM (+0.99%), MBS (+5.39%), SSI (+2.61%), VCI (+0.96%), VDS (+6.92%), and VND (+1.35%).

The VNIndex still closes below the 50-period moving average, showing a short-term downtrend. That means the downside risk is still intact. Hence, traders should be careful and reduce long positions.

The VNIndex maintained its downtrend last week for the second week in a row due to the effect of the long holiday.

The VNIndex closed below the 100-period moving average, showing a downtrend in the medium term. If the index still is below the long-term moving average, the medium-term trend will be confirmed.

In the short term, the index crosses the 1,050-pts threshold, showing a bearish market. Besides, the liquidity decreased to confirm the current trend. Therefore, the index may retest the zone of 1,000-1,020 pts in the future.

Notable, the long holiday impacts price and volume next week. The 1,100-pts area is strong resistance. In addition, the 1,000 zone shows significant support.

 \rightarrow The VNIndex shows more bearish signals due to closing below the 1,050-pts threshold.

▶ Technical strategy: Stay on the sidelines

In this case, the downside is still intact due to high selling pressure around 1,100-pts threshold. Therefore, traders should stay on the sidelines and wait for the next signals.
