The VN30 index formed the closing price at 1,089 pts. Relating to foreign trading activity, supply came back to high level with net sell value was VND250bn, mainly driven by large sell orders on STB, SSI, and MSN.

VN30 Future chart: Rebound phase

Bearish swing is paused on VN30F2304 due to the increase of demand near 1,000 pts zone. If the 1,000 pts area is broken, 900 pts zone would be the next destination. The rebound phase will be completely active if the 1,100 pts zone is broken. Bearish swing is still active due to the unformed higher high pattern. With short-term movement, the instrument is forming the slow bullish swing as well as major short-term MAs are broken. Notably, total OI (Open interest) came back to above 50,000 contracts, implying the high probability for the upcoming market leg which would end the current consolidation phase as well as there is high probability for the upward swing.

Technical strategy

Long VN30F2304 after ATO session and stop the loss when there is the closing price below 1,030 pts level. (Hourly chart)



Figure 1. VN30 Generics hourly chart






Figure 2. Basis spread

Figure 4. Open interest pattern




