## **VN30** performance

The VN30 index formed the closing price at 1,062 pts. To be specific, KDH (-3.2%), NVL (-2.6%), TPB (-2.5%), VPB (-2.0%), and SSI (-2.0%) were top 5 index laggards. Relating to foreign trading activity, demand came back with net buy value was VND200bn, mainly driven by large buy orders on HPG, VHM, and POW.

### **VN30** Future chart: Expiration date

Demand has increased strongly near 1,050 pts zone, confirming the valid rebound phase and increasing the tendency to retest 1,100 pts area. However, selling pressure is still strong near 1,060 pts zone which means the current intraday rebound could be faded. Major Mas on wider charts show no sign of upcoming valid market leg. On Hourly chart, the intraday rebound phase is paused but the instrument has high probability to enter the high volatile trading period. 1,050 pts zone is the demand zone for the rebound phase which has low probability to be broken in the short-term. VN30F2305 is expired on this trading day which means new positions should be stalked on the upcoming contract (VN30F2306).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




